## MINUTES OF THE MARTIC TOWNSHIP BOARD OF SUPERVISORS Work Session

**DATE:** October 14, 2025

PLACE: Township Building, 370 Steinman Farm Road, Pequea, Pa. 17565

ATTENDANCE: Jay Kreider, Beth Birchall, Ryan Fisher, Kevin Boyer, and Charles Stouff were present

## **ORDER OF BUSINESS**

CALL TO ORDER: Jay Kreider called the meeting to order at 6:35 pm and led with the Pledge to the Flag.

Dave Williams, Road Foreman has provided information for the 2026 Tar and Chip. He is planning on seal coating Stump Road and the Lakewood Development. The total will be \$190,000. This will be included in the budget.

Dave Williams has received an estimate from Drumore Township for the Magnolia Drive culvert replacement. As this project is on the Township line between Drumore and Martic, at a previous meeting the Board approved replacing this culvert and splitting all costs with Drumore. Drumore Township has taken the lead on this project and Dave Williams received an estimated quote for the Aluminum Box Culvert System which totals \$48,000. Ryan Fisher made a motion, which was seconded by Kevin Boyer to approve the cost share with Drumore Township, contingent on DEP's approval. The motion passed 5-0.

Rawlinsville Volunteer Fire Company – Nick Rhinier presented to the Supervisors two projects they hope to complete in 2026. They would like to place 13 cameras to help monitor the property and surrounding area. Christiana fire company had a theft in June and even with a local police department, did not notice the theft until they showed up for a call and things were missing. Rawlinsville hosts the annual Mud Sale and are planning another Fall Fest, which invites more of the community than normally visits the facility. He has received a quote from Vector of \$31,000 and is planning on meeting with another company to get a quote. RVFC is planning on meeting with Providence to ask for help, as well as Eshbach Busing Company, as their buses sit on the back lot, when school is not in session. JJs has also stated, since cameras will be facing toward the back of this lot, he will contribute to the purchase. Jay Kreider asked if anyone has ever contacted the businesses at the Buck, for donations. as he knows that the DEP study suggested this to get contributions, not specifically for the cameras but in general. Ryan Fisher asked if anyone has contacted the insurance company to determine how much of an insurance reduction they may or may not receive. At this time the ones monitoring the cameras on their phones, will be the Chief, President and Vice-President. The cameras will be motion-activated, and they can control the level of motion intensity. He also thanked the Board for its many years of support.

The second item they would like to do is to purchase 5 more voice pagers for new members. Since the area has a lot of dead zones, the pagers are the only thing that works. The cost would be \$841.25/unit for a cost of \$4,206.25. It was noted that in the past, pagers were purchased with the RVFC Relief funds. Jay Kreider thanked him for the information he provided to the Board.

Discussion continued on the 2026 Township budget.

The next meeting of the Martic Township Board of Supervisors is scheduled for November 3, 2025, at 7:00 p.m. at the Municipal Building.
