Application #1 of PPL Holtwood LLC c/o Talen Energy, 600 Hamilton Street, Suite 600, Allentown, PA 18101, requesting a variance from Section 804.K for use and time limitation to obtain a zoning permit and complete construction. This applicant was granted conditional approval with a Zoning Hearing Board Decision, dated January 26, 2021, and they wish to amend that Decision to allow the applicant to complete construction within 2 years of an amended decision. The applicant proposes that all other prior approvals and conditions remain in full force and effect except as modified by an amended decision.

The properties are identified as 430-38050-0-0000, 430-76190-0-0000, 430-96450-0-0000, 430-32623-0-0000, 430-13508-0-0000, 430-82698-0-0000, 430-99497-0-0000, 430-93109-00000 and 430-04506-0-0000, all in Holtwood, Pennsylvania. The Applicants are proposing to place on the coal ash disposal impoundment ground-mounted solar arrays. All the parcels are located in the Rural Conservation zoning district.

Application #2 of PPL Holtwood LLC c/o Talen Energy, 600 Hamilton Street, Suite 600, Allentown, PA 18101, requesting a variance for Uses and Structures, pursuant to Zoning Ordinance Sections 401.B, a variance from Section 804.K for use and time limitation to obtain a zoning permit and complete construction. This applicant was granted conditional approval with a Zoning Hearing Board Decision, dated January 26, 2021, and they wish to amend that Decision, by revising the solar panels from 'fixed tilt' to 'tracking' panels; decrease the number of solar panels from approx. 69,000 to approx. 44,000; expand the array to the south in the area adjacent to Ash Basin 1; to allow the applicant to complete construction within 2 years of an amended decision. The applicant proposes that all other prior approvals and conditions remain in full force and effect except as modified by an amended decision.
